

#### Finding Purpose & A Voice In General Service

My journey in general service started a lot like my journey in A.A. In fact, I became a GSR for the same reason I have almost always done things - sober or not; I wanted to belong, to have a purpose both meaningful and deep. A little before I turned three years sober, I took a GSR commitment in my homegroup. Save for the announcements at the end of meetings, this side of the program was foreign to me yet the concept of being a messenger greatly intrigued me. A.A.'s strong sense of community and structure also appealed to me. Additionally, I longed for a voice.

As a child, my parents, and thus my life, were ravaged by alcoholism. My father was a drunk who believed A.A. wouldn't work for him - despite refusing to try the program - and my mother was an untreated Al Anon in deep denial. Both were abusive. Between the lack of security and care in my home and confused, overgrown emotions, my disease was off and running. Around 8 years old, I started turning to "feeling" good rather than

doing good. I took my first drink for the effect around 13, however, I can remember emotionally checking out countless times before that age. As a result, I was rudderless in the sea of life practicing little to no respect for or protection of myself or others prior to getting sober around 25. Simply put, I lacked purpose.

Fortunately, living a life ruled by emotions landed me safely in the open, transformative hands of A.A. At last, I found my people and purpose! From those meetings in my early days, I felt the sunlight of the spirit and the strong sense that I had nowhere to go but up - provided I put the program first in my life.

Through stepwork, I claimed my seat in these rooms in more ways than one. The inventory process showed me the disconnection starting in my childhood had to do with my parents' diseases. However I also learned that I was a victim of my own illness. Shocked doesn't

begin to describe how I felt learning that I had been a slave to my own emotions. At three different points in my teens, I was admitted to mental hospitals due to an unwillingness both to care for myself as well as refusal to accept help from the caring hands of others. Each stay was the result of me living in what I have come to understand are my character defects.

Flash-forward to being a GSR, I took on the commitment because I

believed it would do a couple things for my program. First of all, I had grown because of A.A. so to show my appreciation, I chose a commitment that would both ensure I regularly attended my homegroup as well as the monthly district meetings, and one that would deepen my understanding of what and why we do what we do in the rooms. The more A.A. the better! Secondly, as a child, teen, and young adult, I felt alone unheard and ineffectual. Since day one of my time in A.A., I felt pride in belonging to our fellowship, in fact it was like a family to me. That love and appreciation drove me to deepen my experience through general service.

Service was and still is my solution to my disease and defects. My involvement in general service broadened

my network of people in recovery and helped me find a bigger higher power as well as share the message with others. Through letting others love me, I began to love myself. With that self-care came an ability to care for others and give. Those same loving arms that embraced me as a newcomer at 25, welcomed me at 29 to the world of general service.

During the same time I took on the GSR commitment, I was also applying to colleges. A.A. gave me the opportunity to chase my dreams, to live a big, beautiful life - so I did. After serving my thenhomegroup as GSR for a year, I moved out of my area and district onto the next sober adventure. Now 35, with 10 years sober, I find myself living in yet another part (and district) of my native Southern California. Early on in A.A., I learned to dive headfirst into the program so when a meeting I was regularly attending needed a GSR, I jumped at the commitment. This

time, I had not only willingness but experience and was elated to serve. What's more, I also had a bachelor's degree in creative writing so at my first Area Assembly in this term, I followed my smart feet and open heart towards a friend's committee and offered my hand at writing for SCAAN.

Gone are the days of a sad, fearful child in the body of a young woman who cried hopelessly through her first

year. Before my homegroup and in assemblies now stands a strengthened, inspired young woman with bright eyes and a proud voice ready to share the message of the program that gave her life! Through being a GSR, I learned that my unique, rolling stone lifestyle as well my youthful, optimistic outlook could benefit A.A. by offering hope and open mindedness as well as growing further with my sober service kin, carrying the message to new friends in my homegroup, and extending my understanding of A.A.'s code of love and tolerance on a broader scale. Thanks to general service and A.A. as a whole, I found my voice.

### DELEGATE'S REPORT

I was so looking forward to the 70th General Service Conference (hereinafter GSC). I did not constrain myself from making plans for before, during and after the GSC. I had listened to many stories from Past Delegates, the General Service Office (hereinafter GSO) staff and Trustees. The 69th GSC was an unbelievable experience in Manhattan, New York. The 70th GSC was to be held in Rye, New York. The experience would be new, different but exciting, to benefit Alcoholics Anonymous.

When Covid 19 restrictions on the number allowed for gatherings and social distancing became a reality, my throat sank to my belly. All I could suppose was that the 70th GSC would be cancelled. I could not conceal my disappointing thoughts. I had no knowledge of Zoom. Then my local meetings became Zoom Meetings but I couldn't imagine the GSC Zoom. How would we even vote, nonetheless 3rd Legacy voting?

The Pacific Region Trustee started scheduling conference calls, then Zoom calls. My conference committee, The Conference Committee on Trustees, scheduled conference calls, then Zoom calls. Seeing the Zoom technology being used for the GSC was still vague. Besides, the GSO was closed due to Covid 19. How could it even be planned? The indomitable spirit of Alcoholics Anonymous proved everything I thought wrong. The news came: the GSC would be virtual. 4 full days were scheduled, May 16 - 19, 2020. My thought was how I would physically be able to sit in front of a monitor 8 hours a day for 4 straight days, not how much could we get done to benefit A.A. Conference committees were tasked with determining which agenda items were essential, those must be resolved first. Which agenda items were important and should be considered? Which agenda items could be deferred to the 71st GSC in 2021 without being considered? I was so impressed with our GSO.

The Conference Committee on Trustees is tasked with reviewing the qualifications of Region and At

Large Trustees and participating in their elections. We review the slate of Trustees and Officers of the General Service Board (hereinafter GSB). We review the slates of Directors for our 2 publishing corporations. These responsibilities are essential. They were a must on the Conference schedule. We were also tasked with reviewing the GSB's progress on a Board Reorganization Plan. We chose not to defer it.

So the 70th GSC took place. I suddenly realized I was on the side of history. A virtual Conference had never been done and now we know how to do it. Perhaps a total virtual Conference may never be required again but every aspect of what occurred is not going away. There was great value in the Committee process, meeting before the Conference, getting to know one another and sharing ideas.

I gave my first Report Back May 23rd at the 3rd Legacy Meeting. After the June 7th Report Back another is scheduled at the July 25th Assembly. I am available.

Our Alternate Delegate has forwarded the Conference Agenda Items which also indicates those deferred and the Floor Actions from the Conference. Please print and have available throughout this virtual Assembly. It should provoke thought and questions.

## SERVICE IS A WAY OF Being An Interview With The CYC Chair

#### When did you get sober?

Feb 1, 1996, so I'm 19.

#### When did you start being of service?

From the very first meeting I went to I was of service. It was a Young People's meeting, but I didn't know that's where I was going. A guy I knew picked me up and took me there. An hour before the meeting started, I met the woman who would become my sponsor, and she told me, "Never go to a meeting and not be of service." At that meeting not only did I get a sponsor but I also met this whole crew of people that I could hang out with. They invited me to an All California Young People's Conference. They said, "Hop in the car, don't worry about money. You can crash on the floor." It was amazing. I think I probably had 3 weeks or a month of sobriety at that point. The way it works in the Bay Area (I got sober in Oakland) is everyone was involved in general service. Even at the first meeting I went to there was a GSR meeting. Every month there was a GSR meeting, separate from the regular meeting, so my exposure to general service began in my first 30 days of sobriety.

I also found out there was a Young People Committee in the East Bay. I did a lot of H&I work and Young People work. The Young People Committee hosted a couple of conferences. I even went to international conferences. We used to also have this thing we would do for the Central Office, phone answering parties. The Central Office could forward the calls to your phone, so we could be eating and listening to music, but when the call came in we would get quiet. They were great. Yes, service was a way to save our asses, but it was more about how we lived and what we did.



#### When did you become a GSR?

The first time I was a GSR was when I was six or seven years sober.

### How did the ad hoc Cooperation with the Young Community (CYC) Committee come about?

It was either panel 65 or 67. There was something on the agenda for a desk opening at the General Service Office for Young People in A.A., since there were so many groups and committees for young people. This request got a conversation going about what it would look like or how a demographic of alcoholics could benefit from a committee and/or services that were dedicated to them.

My understanding of general service is that it's the hand of A.A. reaching out to (1) those who might not have found it or (2) the places where people can't find it. This could be done via literature and the other

committee work we have going on, like Cooperation with the Professional Community, Treatment & Facilities, Corrections, etc. Young people seem to be a forgotten demographic since, in my experience, a lot of people don't see that a 12-year-old could be an alcoholic. They might even say, "Are you sure you're an alcoholic?" when that young person walks into a meeting.

I know there is a lot of misunderstanding about who A.A. is for, so we wanted to make sure that the places where young people are and the people who work with/and for them know that there is a safe place for young people under 25. Who I would love to get services for would be those as young as 10 years old. I think there's a lot of stigma and beliefs about how young people drink. Studies show that adolescent drinkers binge drink which might be different than how others drank. So it's important to give a face to what A.A. looks like for young people. Right now we have been getting out to Young People meetings to get volunteers. We want the folks who got sober young to be used as a resource and provide them with a unique service opportunity.



### What have been some of the successes of the ad hoc CYC Committee?

It's hard to say. I know one thing I immediately think of is all the emails I'm getting forwarded, which are requests for information about what we do. We are seeing more and more areas adopting a young people committee and liaison, and CYC is able to be a resource for them. They ask questions about what they should be doing, what the scope is, and how to get started. We have a list of activities that we can promote and share.

The other big thing that has come out of it is The Void, which is a resource for young people who may not know what A.A. is about. The Void is really targeted for those who are not in A.A.,

so there are suggestions for those who are trying not to drink, defining A.A. terms, providing meeting information and outlining what A.A. is and isn't. Another great thing is that the L.A. Central Office knows we exist. I think it was in January of 2019, at the beginning of our committee work, when they reached out to us to see if we knew of anyone young who could do an interview for Buzzfeed.

In general, because CYC is normalized and there's a committee, it is promoting inclusivity. It should be noted that we are not just doing stuff in our committee but in other committees as well. While there might be times when a young person comes into a meeting and old timers don't know what to do and how to support them, we are hoping to provide resources so everyone feels informed.

#### What is the origin story of Summer Service Camp?

I love the origin story of Summer Service Camp. It was me having conversations with a couple of people. I would have conversations with Jon. I'd have conversations with Amelia. And they would be conversations about concepts and traditions. It would be hours that we were having these conversations, whether they were after district meetings or before meetings. It was really about noticing the gap in understanding and making service a way of being, rather than something we do. There seemed to be a disconnection and a steep learning curve. We wanted to help with that. When you are a GSR the meetings are once a month, so general service can be hard to figure out. Whereas when you get sober you are encouraged to go to meetings daily, so you can figure out the lay of the land ... the prayer at the end, the stacking of chairs, etc. The learning curve is less steep since you are doing it daily.

At some point I said, "I wish we could sit around a campfire and roast marshmallows and talk about this stuff." We knew we didn't want to keep it to ourselves, so we thought about seeing if GSRs would want to do it too. Then I was in a meeting for another fellowship and I saw a flyer for a summer camp. I called Jon hesitantly and said, "Summer camp?" I called Amelia and asked her the same thing. They were both excited, so we started planning it. It was this dream we had that was about wanting to be engaged and hear the stories about what can happen when one person works with another person. We wanted to hear about those times that make the hairs on your neck stand up, those times where you hear about a matter of minutes making the difference in the future of a person. For example, we were at an A.A. conference in Pasadena a long time ago. There were a bunch of us and we were waiting to cross the street. This bus pulls up and a young guy gets off. He walks over to us and asks, "What's happening?" No one wanted to answer because we didn't want to reveal we were in A.A.. Finally, I said "We are going to an A.A. meeting." He responds, "I just got dropped off from Twin Towers. I just got discharged on an alcohol related offense and need to get to a meeting. Can I come with you?" And he came with us. So, we wanted camp to be about sharing these stories, these times in our sobriety. We wanted it to be about engagement, rather than the committee. We wanted to talk about how we live and breathe service and the growth in our recovery.

During camp there were panels and meetings. There were things we did this year to integrate all 3 sides of the triangle that were really, really amazing. The first session was an intention-setting meeting, where we looked at the things that are holding us back in service and recovery. We closed the weekend with what we called the "whisper walk" where we had people lined up and walking blind folded. This might sound woo woo, but it was a time that allowed people to hear from the universe exactly what they needed. Everyone was in tears. It was really powerful. Of course there were games, like color wars and team games, as well as bonfires and meetings and love and connection. It should be



noted that it's not just for young people. It's for all ages. We have realized that camp can't just be about service, it needs to be about *everything*. Which is how we came up with Camp Spirit Fire.

#### Why do you think service work is important?

Service allows me to get out of myself. Service provided a shift in my perspective, helping me to see how I can connect to others and how I can be useful to the world. I bring this everywhere I go. This is important because when I came in I was filled with shame. I was broke, I was hopeless, I felt rotten to the core. But being able to turn away from myself and to see how I can be useful and turn to God and other humans, helped me to have a sense of purpose and be able to lay my head on the pillow at night and to know that I had a good day. It reinforces hope and love that is beyond recovery and is about a connection to the world. That is what service gives to me.

### The CHALLENGES And TRIUMPHS Of Virtual Meetings

Greetings from your Alternate Delegate - in quarantine! This is a confusing and worrisome time so I am grateful for this chance to connect with you.

Your SCAAN chair, Ken T., asked me to write an article about "The challenges and triumphs of the first-ever virtual pre-conference workshop!"

As you know, due to the COVID-19 Pandemic, we had our first pre-conference workshop virtually via Zoom meeting on April 5th, 2020. We had around 125 people in the meeting from our area and many other areas around the country including our Pacific Region Alternate Delegates and Delegates, with Spanish and ASL interpretation going on simultaneously. The presentations were remarkable with our members going the extra mile deep into the background material to give us an effective report. Your web Committee, including Chair Shawn A. and Webmaster Faith B., made everything available online very early which was a great help. We were also graced with a wonderful presentation about the General Service Office and the Conference by the Staff Coordinator of Regional Forums at the General Service Office Sandra W. I cannot thank them all enough. Our Delegate Thomas S. was able to take copious notes and received good feedback from the fellowship after each presentation. Thank you for your participation. History was made! The online surveys were completed by 93 A.A. members and Area members combined and have been compiled by our webmaster into a report of 164 pages - how significant this is!

The challenges associated with our situation of being apart physically are many. Communication is via phone text and email only now and so there is a large amount of time spent in front of the computer screen. Letting people know how we were going to have our workshop was a challenge. This meant me sending out a LOT of emails to encourage DCMs, DCMCs, Committee

members, and Past Delegates to attend and get the word out. Of course, I am always online or by/ on my phone all the time but I knew many would not be, so I kept getting the word out the best I could. Now we are able to text the entire area for even more accessibility.

The Zoom Meeting - well, that was another story. I started working on that on March 10th. In my daily work I have used Skype for my clients and various other recording software to connect but I had never used Zoom before. The biggest complication was making sure we had the right package for our needs so there was some time spent on the phone and email with a Zoom sales representative to make sure we had room for enough people, enough time for the meeting selected and the accessibility for interpretation. The new Technology Ad-Hoc committee chaired by Kyle H. and our Spanish Interpreters Patricia H. and Lorena P. were immensely helpful as we learned the program together and had several trial run-throughs. Right at that point, it became almost impossible to get tech support from Zoom! Everyone had discovered the platform and they were not ready for that! I was on the phone at 1:00 AM with a Zoom Tech in Australia and he and I finally figured out the interpretation program together. As for our ASL members we learned that the watcher could "pin" the video of the interpreter on the screen to watch. What a wonderful thing that is.

Since the pandemic began I have been on numerous meetings on Zoom and on conference phone calls. I was in Alaska, Hawaii and Northern and Southern California for their pre-conference workshops, have been on local A.A. meetings, had Officers meetings, District meetings and Steering committee meetings as well as both H&I and our L.A. Central Office and the Foothill Roundup Committee. We are making history here out of need and after this is all over, we will have the technology to help connect when we cannot meet together. This can allow Committees at the area

to meet outside our assembly and work better together as well. There will be a renaissance!

As many of you know, safety was a problem early on with "Zoom Bombing" occurring in meetings listed on the web. We have learned from these mishaps to add a monitor and waiting room with access to eject these people immediately. This is another thing that Zoom has been trying to catch up with.

As a side note, as you will hear from our delegate, the 70th Annual General Service Conference was virtual for the first time this year. Your delegate has worked extremely hard in the past months having his two committee meetings, Pacific Region Meetings, Delegate meetings and much, much more in the months leading up to the Conference. He has taken his service responsibility seriously, and we will reap the benefits of that.

There is still a problem though, and it is real. Many of our members don't have computers or access to one, and some do not have cell phones either. We are unable to reach these members during this time and that is very frustrating for them and us. Until we are able to see each other physically I think it is upon all of us to reach these people somehow. Home phones ring too! GSRs can help by getting phone lists from our roster and their districts and DCMs can reach out to their committee members via landline to inform them of what is going on in the area and A.A. as a whole. I hope that conference calls are a part of your communication too if needed.

All of the officers of Panel 69 are dedicated to keeping us informed and in touch while we cannot be together. There is nothing like being together at an assembly though, and I hope that will be coming soon. Until then I hope you and your families stay safe and healthy until we can be together again.

As always, I am available to you through all of this.

Reading Our Great Responsibility: A Selection of Bill W.'s General Service Conference Talks from 1951-1970 was like entering a time machine - transporting me instantly with every read to the smell of rooms

filled with the scent of wool and tweed suits, cigarette smoke and strong, percolated black coffee. This easy and inspiring read contains sixteen perfectly transcribed addresses from Bill W. to the General Service Conference. Due to the fact that the addresses given were so well transcribed, reading Bill speak felt much like listening to one of our Trustees or Past Delegates speak at PRAASA or an event like last year's inaugural Unity Forum. His thoughtful and entertaining presence jumps off of the page and feels as familiar to me as the warm feeling I get while attending my home group and

hearing the speakers invigorating forty-five minute share.

Though his idea was initially met with much resistance from every direction, including from his co-founder Dr. Bob, with a steady persistence, as we do when trying to change anything in A.A., the First General Service Conference met in 1951, the year my father was born. Which now connects

me personally to such a monumental event in our fellowship's history to my own.

This special publication gives us all a peek into this groundbreaking part of A.A.'s history using beautifully documented black and white images capturing candid moments at various conferences, many seen for the first time. Other photographic highlights I enjoyed were the many archival images of flyers, pamphlets, scribbled memos, reports and bulletins in perfect color, many still

displaying their worn and tattered edges. I believe that the more than sixty archival images was a wonderful balance to the talks, further giving me the feeling that I was almost there with them myself.


Overall, Our Great Responsibility gave me a much deeper insight into the growing fellowship I love so dearly and that has given and continues to give me so much life.

### **DIGGING INTO A.A. ARCHIVES**



- 1961 Area Assembly minutes
- 1980 District boundary descriptions
- Original pamphlet written and approved by the Area
- Description of District 13's move to its current meeting location

These are just some of the archival papers that the Area Archives Committee has found recently.

The Archives are in a storage facility with a typical storage locker. While this works as a place to keep the boxes of documents and pictures, there is no place to take out the boxes and look over the contents. Thanks to one of the Committee members, we have arranged to rent a meeting place once a month for a "sorting party" where we empty storage boxes to look at and sort the papers.


The room we rent has a large table with lots of chairs around it, and plenty of room to spread out papers. We are sorting the documents into categories and making sure they

are protected and laying flat. We are also removing any staples or metal paper clips so they won't rust and ruin the originals.

People sometimes wonder whether archives are valuable, and how they are used. When the Area can, the Archives Committee wants to get a good document scanner in order to digitize our collection. This will make it useful for research. For instance, just from digital copies of flyers from the 1980s and 1990s donated by Mid-Southern California Area 09 Archives, we were able to piece together the history of the Four-Area DCM Sharing Session.

We were also able to give the Area Registrar copies of the District boundaries as they were described in the 1980s to help her in her project to identify all of the exact District boundaries. Our Literature committee wanted to see a copy of the "Ordered to Attend" pamphlet developed years ago by the Area, and we now have a copy to give them

District minutes, flyers, and newsletters will be a valuable addition to the District pages on the future Archives website.

The only hindrance seems to be the tendency of Committee members to read most of the papers we come across. Everything is interesting to us, and we spend a lot of time saying, "Look at this!" and showing or reading documents to the other members.

Obviously, our work has been put on hold while we all stay at home during the coronavirus pandemic, but we plan to continue as soon as we can.

### Area 05 In Tech: "We Are Making History"

In a world where doors are being shut, social distancing from loved ones is expected, and isolation is being enforced, many within our A.A. community are struggling with the loss of human connection. Receiving support from others is important for maintaining our sobriety.

Alcoholism is already a condition of isolation

backed by anxiety and depression. So now, with social isolation being forced upon us, we are even more alone than ever. In this time of the coronavirus, we could not have predicted all the ways the power of Zoom meetings would facilitate the social-distancing lifestyle or how it would keep an alcoholic like me

plugged into the fellowship.

Areao5 has been discussing how to reach remote communities for years. At the last National Alcoholics Anonymous Technology Workshop (NAATW), we all saw the benefits of technology in action when our panelists joined us from China, Australia and elsewhere. Whether geographical distance between meetings or the social distancing between individuals, I was witness to how technology can carry the message.

On the last Saturday of March, nearly 3 million people globally downloaded the Zoom app on their mobile devices for the first time—a record for the company. It is now reported that they had 200 million daily users in the month of March. That's a lot of connection and what a blessing to have the Zoom tool available to the A.A. membership.



As our Delegate and Alternate Delegate like to say, "We are making history." I look forward to getting together with my home group and visiting that traditional Saturday morning meeting. However, I am pleased that this pandemic has forced me to nurture my sobriety with new

types of meetings. It has continued to feed my soul when everything else can be overwhelming.



#### <u>Introduction of new General Service Representatives and Alternates:</u>

New General Service Representatives and Alternates came to the microphone and introduced themselves and their respective District.

#### **Approval of the Agenda**

Chairperson Zoraida R. presented the Assembly Agenda. Noted the agenda printed in the SCAAN has changed. Added WACYPAA presentation, PRAASA 2023 Committee report, New Business proposal from Guidelines and Policies, and Spanish Foro. *Made a motion to approve the agenda as amended. Motion was seconded and approved. None opposed.* 

#### **Approval of Assembly Minutes from October 20, 2019:**

The Secretary advised that the Minutes of the October 20, 2019 Assembly were printed in the SCAAN (Area 05 newsletter) which had been distributed for approval. *Motion to approve was seconded and approved. None opposed.* 

#### **Approval of 2020 Area Calendar:**

The Secretary advised the proposed 2020 Area Calendar was distributed in the SCAAN (Area 05 Newsletter) on page 9. There was one typo on the English version "Notes" section had incorrect date for the 02/23/20 ACM. District 33 DCM indicates the Spanish Foro Committee agreed to host their event on 1st Sunday in November (11-01-2020). They normally set the date and would appreciate input to the calendar as they're autonomous. *Motion to approve was seconded and approved. None opposed.* 

#### **Unfinished Business:**

Revised 2020 Budget (*Finance Chair*, *Nadine S.*). The Finance Committee Chair presented the budget, which was approved at the ACM in November, 2020. She described the budget process and indicates this year's budget is 'balanced' and asked for comments or questions. Motion to approve was made, seconded and approved. None opposed.

#### **New Business:**

Presentation of Motion to Clarify Voting for Alternate Chairs, DCM's, and DCMC's (Registrar, Nikki U.) Nikki presented the motion and background. <u>The following was a presentation only. Not voted on today.</u>

<u>Motion:</u> I move that the following sentences be added to the end of paragraph 2 of Sections B., C. and D. of Article IV. Of SCAA Guidelines and Policies:

"In the event, an individual serving in multiple capacities, for example Area Committee Chairperson and District Committee Member, is required to vote and no Alternate is in attendance, the individual shall cast a single vote in the capacity of their choice. Should a single Alternate also be in attendance, then the Alternate will cast the vote for the service position for which they are an Alternate and the individual

will cast a vote for the position for which there is not an Alternate present. Should multiple Alternates be in attendance, then the individual shall select the Alternate who will vote by either lot or coin toss and the individual serving in multiple capacities will cast a vote representing the service position that is not given voting power by lot or coin toss. This selection of voting Alternates should be made among the parties at the beginning of the meeting and will be in force for the entirety of the meeting."

Presentation of Motion for New Guidelines on Area 05's Process for Proposing Conference Agenda Items (Guidelines & Policies Chairperson & Panel 67 Past Delegate, Thomas B.). <u>The following was a presentation only. Not voted on today.</u>

#### **ARTICLE XIII**

#### How SCAA Area 05 Recommends an Agenda Item to the Conference

Per the A.A. Service Manual, a good idea for improvement of AA Literature, policies or finance can come from anywhere within our Fellowship — from an AA Member, a group, a district, an area service committee, the area committee, an assembly, a delegate, officer, trustee, or GSO staff person (see Service Manual, Chapter 7, The Annual Conference Meeting, "Sources of Agenda Items"). Nothing in this Article is intended to discourage or prohibit submission of a Conference Agenda Item suggestion from any of these sources.

But if a Conference agenda item suggestion is to be recommended by Southern California Area o5 as a whole, then our long-standing practice to insure due process and full consideration requires that any formal recommendation by Area o5 of a Conference Agenda Item be vetted in the manner described below:

A Conference agenda item to be recommended by SCAA Area 05 as a whole requires:

- 1. That the text of the Conference Agenda Item proposal together with any supporting background information be (1) presented in writing to the Assembly in English and Spanish, (2) presented, discussed, voted on and approved by over a 2/3rds substantial majority vote of the next Area Committee, and if approved, (3) presented, discussed, voted on and approved by over a 2/3rds substantial majority vote of the following Area Assembly. In all instances, minority opinion shall be asked for, expressed and considered, and an opportunity for re-vote, when applicable, shall be afforded.
- 2. Upon the Area's approval of a Conference Agenda Item suggestion through this process, the Delegate shall submit the Conference Agenda Item suggestion to the Conference Coordinator by the date Conference Agenda Item submissions are due, along with its background information and a description of the Area's vetting and approval process.
- 3. The above approval process shall also be applied for any Area recommendation of an AA Service piece to the General Service Office.

**PRAASA 2023 Committee**: Thomas B., Committee Chair, presented on the planning. Thomas presented, for the past year the Past Delegate's, which make up the Host Committee, sent Request for Proposals to local hotels. Negotiating contract with LAX Marriott. More will be revealed. They're making good progress on the planning.

WACYPAA Report Back: Oscar: WACYPAA is the Western Area Conference of Young People in Alcoholics Anonymous. They just hosted large A.A. scale conference in Area 05, in early January. Thanked all those that participated: General Service Representatives (GSRs), Hospitals and Institutions (H&I), people from out of state, and hundreds of newcomers for their first A.A. experience. You can have fun in A.A. Dates were 01/02-01/05), in downtown Los Angeles. Kyle: Registration chair for 2023. 1375 people attend the conference. Additional: The organizing committee is going to visit Districts with sole objective to encourage GSRs to motivate their groups to attend the Forum. They will visit District 34 and will work with the Area as well.

- Nadine S., Finance Committee Chair: Admits to being a Bleeding Deacon. Taught her to be patient with other people. Helps at her job and in her life. Greatest thing that has happened in her sobriety.

**Lunch:** Assembly broke for lunch. Estimated Cost for Breakfast and Lunch (Finance Chair, Nadine S.) is \$1012.00. Since there are 150 people present, the cost is \$7.00 per person. Thank you!

#### **Delegate's Report**:

Thomas S., reports: Expresses his gratitude for privilege to serve as Area 5's Delegate. Greatest honor of his life and quite a responsibility. Explains the Panel is two years and the last calendar year was successful. Discovered that nothing is accomplished alone. Thomas thanked Past Delegates for their contributions to his ability to carry out the position. Thanked Area 5 Officers as well. Area 5 is respected and well represented by other Areas and the General Service Office as well. Gave special thanks to Alt. Delegate due to how closely they work together. Pre-Conference workshop prepares him for the General Service Conference. Lauren has become his sister in Service.

Orientation: There were 25 new General Service Representatives (GSRs) in orientation this morning. To those GSRs, and all the District Committee Members (DCMs), District Committee Members Chairs (DCMCs). Thomas suggests they reenergize themselves by reading the resolution (page Sro3 of most recent version of the Service Manual): Bill's and Bob's turnover of the responsibilities of A.A., the institution, to all of us (the A.A. members). Collectively, across the North American Conference (U.S. and Canada), has taken all of us to replace two founders. It is our responsibility to preserve the 3 legacies of General Service: Recovery, Unity and Service). Delegate's Report in the SCAAN: of hearing a Past Trustee talk about the one legacy members of the Fellowship, the two legacy members of the Fellowship. And that we should take pride we're 3 legacy members of the Fellowship. We're the curators of the Traditions and Policies of A.A. We are the senior conference of our worldwide Fellowship. People around the world look to us for leadership.

The Group has entrusted you (us) to representation. Periodically, we should inform the Fellowship of their history, "Why we exist!" GSRs, Groups, District, Area, Region and Conference. And our relationship to the other 30+ conferences around the world! Give them a history and geography lessons.

<u>Area events:</u> Since the calendar is prepared in advance for the entire year, please mark your calendar for the Area event.

<u>Guidelines and Policies:</u> Committees for the past year has done a marvelous job, and we expect that will continue. Ensure we have an up to date Area 5 Guidelines and Policies document available. Perhaps we can copies available for the next Assembly.

<u>Committees</u>, along with their individual work, frequently assist the Delegate directly. Personally thanked Alt. Delegate, Web Site Committee Chair and the Web Master for pulling him out of a hole! Thomas shared he was on a conference call with New York, and had trouble communicating, and they aforementioned helped him resolve technical issues.

<u>Information:</u> We have American Sign Language (ASL) translation, and, whether you know it or not, G.S.O. Publications, now has the Big Book is ASL translation. It's not a written language, but rather visual. If anyone needs ASL literature, such as the Big Book, ASL publications are available.

<u>WACYPAA</u> follow up: Thomas attended WACYPAA conference. Had the privilege to serve as a Panel moderator. The young people in A.A. have abundance of enthusiasm. They welcomed him in their special way.

General Service Office/CPC: G.S.O. receives many requests to participate. Some they solicit to participate, such as, professionals, to have A.A. there as an attraction. This year the Evolution of Addiction Treatment which is being held in Los Angeles, November 3 – 6, 2020. Raymond Y, Cooperation with the Professional Community (CPC) Committee Chair is going. He will need many people to volunteers to support the event. There are 10 months to prepare. He's going to need help.

<u>Subcommittee</u>: Thomas serves on a subcommittee with the Department of Veterans Affairs (VA), which was formally renamed to Joint National Leadership Committee on Whole Health Communication and Education. They are probably tired of hearing from Thomas, continuously express that for Veterans whole health has to include 'therapy for alcoholism.' Combat veterans need this. As a combat veteran, he assures us that to face live combat, they use alcohol and drugs to cope with fear.

<u>Patient Brokering Service Piece</u>: During his November trip to GSO. He presented the Service Piece for Patient Brokering. Does not know the resolution, yet, and G.S.O. is thrilled and had discussions on this themselves. He is hoping literature will be created. However, we locally, any individual meeting, can have a Service Piece on Patient Brokering, without being Conference Approved.

G.S.O. Staffing: There are 13 staff positions in N.Y. Thomas recently received an update from G.S.O., made available in English and Spanish: 1) Brenda Brown was hired and assigned to Corrections desk, which was an open position. 2) Irena Dinoso came over from La Vina and was assigned to Accessibilities and Remote Communities. 3) Communications was filled by Clement C. However, that staff position has become a Department, and is not listed under Staff Positions. He does not know the level of access the Fellowship will have with that department. He has concerns about the change, not with the person, and plans to discuss at the G.S.C. A.A. G.S.O. is now at full staff, since the latter was converted to Department. He has the updated list of G.S.O. staff assignments. Speak with Thomas if you'd like the list. You can make that part of your report to your Group.

Thomas read a portion of the letter from G.S.O.: 'We (G.S.O.) are beginning to update files with applications of those being considered for staff positions. Must have a minimum of six years sobriety, group and business experience, and a willingness to relocate to N.Y. City.' If interested, talk with Thomas or write to Staff Coordinator, Mary Cummings, Box 459, G.S.C., New York, NY 10163.

<u>PRAASA</u> volunteers: Asked for DCMs and/or DCMCs to stand. If they have not presented at previous PRAASA he wants your names. All those still standing are potential presenters at 2020 PRAASA. Needs some presenters under age of 35, and some over the age of 35. Area 5 will have two presenters, we also want three moderators, three readers and two timers for possible selection.

<u>PRAASA 2023 Host:</u> Thomas will serve on the PRAASA Delegate Board (PDB) since we're hosting in 2023.

<u>PRAASA Scholarships:</u> Thomas will submit names to the PDB of those planning to attend that may need financial support.

Area 5 Pre Conference Workshop: Will be held April 4th and 5th. Thomas will attend 70th G.S.C. and is the Co-Chair Remote Communities Meeting along with Delegate from Area 73 (West Virginia). They are developing a Theme. Newsletter: "Remote Communicator" – solicits written presentations which can potentially be in included in the newsletter. Going to define what is meant by 'remote communities.' Not just geographically remote. It's much broader then that! Solicits a 2- or 3-page paper on the following topic, "Challenges and Solutions of Reaching the Spanish Communities," "African American Community," "Deaf and Hard of Hearing Communities," "Homeless," and finally "Veterans." Wants something on each of these topics from Area 5 folks. GSRs please report this back to your Group!

Report Back presentations: Thomas needs to get the Delegate Report Back dates on his calendar. Even though we haven't had the Conference yet, he would like to these set. <u>Approval of November 16, 2020 ACM Minutes</u> Area Secretary, Doug S., presented Minutes for the November 16, 2019 Area Committee Meeting. Thanking the Translation Alt. Chair, Bill L., for his excellent work in translation. Motion to approve was seconded. The Minutes were approved. None opposed.

<u>Approval of ACM Agenda</u> Area Chairperson Zoraida R., presented the February 23, 2020 ACM Agenda. Motion was made and seconded to approve the agenda as presented. Motion passed with none opposed.

#### **Unfinished Business:**

Motion to Clarify Voting for Alternate Chairs, DCM's, and DCMC's, Nikki U., Registrar: Nikki presented the motion and background.

#### **BACKGROUND**

The current eligibility requirements for voting and making motions at Area Assemblies, Area Committee Meetings and Area Steering Committee Meetings are laid out on pages 6 and 7 of the SCAA Guidelines and Policies as revised February 2, 2015 (available on the area05aa.org website).

#### IV. SCAA Meetings

- B. Area Assemblies
- 2. Those eligible to vote and make motions at Area assemblies are GSRs and Area Committee members, or, in their absence, their alternates. GSRs must have been registered with the Area at least 72 hours in advance of an assembly in order to vote.
- C. Area Committee Meetings
- 2. Those eligible to vote and make motions at Area Committee meetings are DCMs, DCMCs, Standing and Ad-hoc Committee Chairs, Area Officers, or, in their absence, their alternates, and Past Delegates.
- D. Area Steering Committee Meetings
- 2. Those eligible to vote and make motions at Area Steering Committee meetings are Area Standing and Ad-hoc Committee Chairs, Area Officers, or, in their absence, their alternates, and Area Officers.

Although not specifically spelled out in the Guidelines, the body has acted on the principle of one person – one vote. Members of the Area of Assembly may on occasion serve in multiple capacities. An individual may serve as both a Committee Chair and a General Service Representative or a District Committee Member or as an Alternate. While multiple functions may be fulfilled by the one individual, there can only be on vote cast.

At the Area Committee meeting held last November 21st, a situation occurred that has prompted this motion. The situation was as follows:

An Area Committee Chairperson, who is also a District Committee Member attended the Area Committee Meeting. Also, in attendance were the Alternate Committee Chairperson as well as the Alternate District Committee Member. When a vote was required, the Area Chairperson, it was discovered that there is no guidance for deciding who would vote and in what capacity.

Here are the possible voting combinations:

- 1. If the individual votes as Committee Chairperson, then the Alternate District Committee Member would vote for the District;
- 2. If the individual votes as District Committee Member, then the Alternate Chairperson would vote for the Committee;
- 3. If the individual who serves in multiple capacities is not present, then the Alternates vote.

The purpose of motion is to provide guidance and clarify voting for those individuals serving in multiple capacities.

#### **MOTION**

I move that the following sentences be added to the end of paragraph 2 of Sections B., C. and D of Article IV. of SCAA Guideline and Policies:

"In the event, an individual serving in multiple capacities, for example Area Committee Chairperson and District Committee Member, is required to vote and no Alternate is in attendance, the individual shall cast a single vote in the capacity of their choice. Should a single Alternate also be in attendance, then the Alternate will cast the vote for the service position for which they are an Alternate and the individual will cast a vote for the position for which there is not an Alternate present. Should multiple Alternates be in attendance, then the individual shall select the Alternate who will vote by either lot or coin toss and the individual serving in multiple capacities will cast a vote representing the service position that is not given voting power by lot or coin toss. This selection of voting Alternates should be made among the parties at the beginning of the meeting and will be in force for the entirety of the meeting."

The motion was seconded. The Chair opened the floor for questions. There were none. Chair opened the floor for discussion. Moved to a vote and the Chair indicates we need a substantial majority (2/3) for the motion to pass. Count: In favor, 19. Opposed, 11. The Chair opened floor to those on the non-prevailing side to discuss their reason 'Why' they voted in favor of the motion (non-prevailing side). Motion did not pass.

Discussion ensued on ways this issue can be clarified. Need to look at alternative solutions. We need to increase participation in the Area. Perhaps all Alternates should vote.

Motion for New Guidelines on Area 05's Process for Proposing Conference Agenda Items, Thomas B., Guidelines & Policies Chairperson & Panel 67 Past Delegate: Thomas discussed purpose of the Guidelines and Policies, and background for this item.

#### **ARTICLE XIII**

#### How SCAA Area of Recommends an Agenda Item to the Conference

Per the A.A. Service Manual, a good idea for improvement of AA Literature, policies or finance can come from anywhere within our Fellowship — from an AA Member, a group, a district, an area service committee, the area committee, an assembly, a delegate, officer, trustee, or GSO staff person (see Service Manual, Chapter 7, The Annual Conference Meeting, "Sources of Agenda Items"). Nothing in this Article is intended to discourage or prohibit submission of a Conference Agenda Item suggestion from any of these sources.

But if a Conference agenda item suggestion is to be recommended by Southern California Area o5 as a whole, then our long-standing practice to insure due process and full consideration requires that any formal recommendation by Area o5 of a Conference Agenda Item be vetted in the manner described below:

A Conference agenda item to be recommended by SCAA Area o5 as a whole requires:

- 1. That the text of the Conference Agenda Item proposal together with any supporting background information be (1) presented in writing to the Assembly in English and Spanish, (2) presented, discussed, voted on and approved by over a 2/3rds substantial majority vote of the next Area Committee, and if approved, (3) presented, discussed, voted on and approved by over a 2/3rds substantial majority vote of the following Area Assembly. In all instances, minority opinion shall be asked for, expressed and considered, and an opportunity for re-vote, when applicable, shall be afforded.
- 2. Upon the Area's approval of a Conference Agenda Item suggestion through this process, the Delegate shall submit the Conference Agenda Item suggestion to the Conference Coordinator by the date Conference Agenda Item submissions are due, along with its background information and a description of the Area's vetting and approval process.

The above approval process shall also be applied for any Area recommendation of an AA Service piece to the General Service Office.

Motion was made, seconded, and Chair opened the floor for questions followed by discussion. Motion passed with one person voted against the motion.
