## The following items are in placed in a large yellow envelope: 'THE PACKET'

Page 5 & 6: Letters in English & Spanish for the Health Care provider.

**Page 7:** We rubber band about (10) Small Information Cards (wallet-size) for doctors to pass along.

**Page 8:** we give (1) both Spanish & English Larger Information Cards (5"x7"). We suggest that these be placed where other employees can view them or in a waiting room.

## 'Talk to Your Doctor' Script for GSRs

"Many of us here today were 'nudged' into the rooms by... a doctor? A judge? A lawyer? Or the reverse happened... we weren't nudged but wish someone in a professional job would've mentioned AA, and we might've gotten here sooner than we did.

There is a committee called Cooperation with the Professional Community, or C.P.C. They communicate with professionals who come in contact with **possible** alcoholics <u>in</u> <u>their line of work</u>. This group *could* include Attorneys, Social Workers, Faith Leaders, Human Resources, or Health Care Providers.

This committee is asking you guys, **AA members**, to share information about Alcoholics Anonymous with your <u>own</u> HealthCare Provider. Think of it as 12th step work; carrying the message to the still suffering alcoholic, **through your doctor**.

They have put together a **Packet** of information to take to your doctor. Each packet contains an introduction letter to the Provide**r**, a handful of pamphlets, & Information cards. These cards have a QR code for the Meeting Guide App to help any patient find an AA meeting.

*Remember*, our primary purpose is to help another alcoholic. By letting your provider know about AA, it may save someone's life."

## THEN pick from the following to close:

(**Remote Mtg:**) "If you think you'd like to do this, send me a private chat and we will mail the packet to you. Thank you."

(<u>In-Person Mtg</u>:) "If you think you'd like to do this, meet with me at the break or after the meeting and I'll give you a packet to take to your doctor. Thank you."

(Hybrid Mtg:) "If you think you'd like to do this, I can give you the packet here in the room. If you are remote right now, let the host privately know, and they can pass on my info. Thank you"

## NOTES:

\* The doctor does **not** need to be in our district.

\* Remind them that **any type of health care provider** can be approached (nurse practitioner, therapist, orthopedic, dentist, etc.).

\* Remember to take the time to talk to <u>a member who is interested</u>. Suggest that they show their doctor the contents in the packet and explain the purpose of each of them. Try to let the Provider leave with the understanding that AA has a *solution* for patients who may be alcoholics.

## "Talk to a Doctor" Script for GSRs

"Cooperation with the Professional Community, or C.P.C., wants to communicate with any type of profession who comes in contact with **possible** alcoholics <u>in their line of work</u>. This group of professionals *could* include HealthCare, Clergy, Attorneys, or Social Workers.

The CPC Committee in **this** district is asking you guys, **AA members**, to share information about Alcoholics Anonymous with your <u>own</u> HealthCare Provider. Think of it as 12th step work; carrying the message to the still suffering alcoholic, through your doctor.

This Committee has put together a **Packet** of information to take to your doctor. Each packet contains an **introduction letter**, a handful of **pamphlets**, and Information cards. These cards have a QR code for the Meeting Guide App to help the doctor's patients find an AA meeting. **Remember, our primary purpose is to help another alcoholic. By letting your doctor know about AA, it may save someone's life." THEN GO TO ONE OF THE FOLLOWING** 

(**Remote Only:**) "If you think you'd like to do this, send me a private chat and we will mail the packet to you. **Thank you.**"

(In-Person Only:) "If you think you'd like to do this, meet with me at the break or after the meeting and I'll give you a packet to take to your doctor. Thank you."

(<u>Hybrid:</u>) "If you think you'd like to do this, I can give you the packet here in the room. If you are remote right now, let the host privately know, and they can pass on my email address or phone number. The packet can then be mailed to you. **Thank you.**"

## **Cooperation With The Professional Community (CPC)**

"I'm a GSR, speaking on behalf of Cooperation with the Professional Community, or C.P.C. CPC's purpose is to reach the alcoholic through a Profession who is providing a service for them, such as a Doctor, Psychologist, Attorney, Prosecutor, Judge, or Therapist. Unfortunately, many of these professionals are unaware of Alcoholics Anonymous and how we could help.

It is CPC's goal to work with **and** educate professionals about how Alcoholics Anonymous works with alcoholics to achieve sobriety.

We are seeking AA members who are willing to share their experiences with **any** Healthcare Provider, <u>and</u> explain how AA has helped *you* recover from the disease of alcoholism.

If you're interested in carrying the message to an alcoholic who still suffers through any Healthcare Provider, I can provide you with a packet. The packet consists of the following: A letter to the provider, AA Pamphlets, such as (*name one pamphlet*), and a copy of the Grapevine magazine. Also inside are large and small Information Cards that have QR codes for the Meeting Guide app.

Maintaining our Anonymity can be a concern. However, the purpose of CPC service work is to share with the public what AA is, what we do, and how to get in touch with us. Our hope is that a Healthcare Provider who hears about AA will know that we offer a solution to alcoholism.

*Remember*, our primary purpose is to help another alcoholic. By letting your provider know about AA, it may save someone's life." **THEN pick from the following to close:** 

(**<u>Remote Mtg</u>**:) "If you think you'd like to do this, send me a private chat and we will mail the packet to you. Thank you."



# More Information FOR AA Members

Our Twelfth Step and our Fifth Tradition both speak to us of carrying the message to the Alcoholic who still suffers.

Do not assume that your Health Care Professional knows what AA is, how it works or that it is a tool available to help their patients.

-Doctors, for example, receive between two and four hours of training in total for alcoholism.

-A study by the CDC found that in 2011, only 1 in 6 United States adults and 1 in 4 binge drinkers had ever been asked by a health professional about their drinking behavior.

-A March 2020 a study by Stanford and Harvard professors was published in the Cochrane Library. The study concluded that AA works! MUST SEE VIDEO <u>https://vimeo.com/378364390</u> Link to video on Stanford/Harvard study video.

\*\* When you go to your Health Care Professional (Doctor, Nurse Practitioner, Therapist, Dentist, Acupuncturist, Nutritionist, etc.) inform them that you are a member of alcoholics anonymous.

Sample Script: "I don't want this to go in my file, but I want you to know that I am a member of alcoholics anonymous. I know that alcoholism has gone way up during the pandemic, and I wanted to provide you with some resources about recovery from alcoholism which may help your patients."

HAND THEM THE HEALTH CARE PACKET

The packet contains:

-Letter to a physician

-Business-sized Cards with contact information that can be given away -Information Cards that can be placed in the Office Workspace for others' to view -(Pamphlet) AA for the Health Care Professional -(Pamphlet) Do You Think You're Different

-(Pamphlet) Is Aa for You?

Finish your conversation with something like: "If you are interested, we offer short presentations to describe A.A. and alcoholism for all professional groups. Most of all, we would love for you to tell us how we can help."

Remember, have confidence in AA. We know it works!
